LDZD — ZADAR/Zemunik Airport - Apron current status and works on the expansion of Main passenger terminal building

1. INTRODUCTION

Current status of Main apron and General aviation aprons are given in Appendix 1 - INDEX CHART "APRON CURRENT STATUS", which is part of this AIP SUP and shows current PRKG PSNs until the new AIP Chart LDZD AD 2.24.2 APDC-1 is published.

Note that INDEX CHART is only indicative, and INS coordinates of PRKG PSNs will subequently be published by NOTAM PERM.

Therefore, all information regarding the AIP Chart LDZD AD 2.24.2 APDC-1 and LDZD AD 2.8 Item 1, Item 2, and Item 5 are temporarily suspended.

Works have begun on expansion of the Main passenger terminal building, with expected duration till March 2026. Check NOTAMs for the respective operational impact.

Due to the closure of the passenger terminal building departure area, new temporary facility visible on INDEX CHART will be installed, with the purpose of creating new passenger departure area.

New stoplines will be installed on PRKG PSN from PSN 1 to PSN 5 on Main Apron.

2. OPERATIONAL IMPACTS

PRKG PSN G3-G15 are CLSD to all TFC at all times, until the finalization of works.

"Follow me" guidance is mandatory on all aprons at all times.

PPR is mandatory for all flights, except those that have already been confirmed according to schedule coordination.

Any subsequent impacts will be published by NOTAM.

3. PRECAUTIONS

Throughout the expansion, pilots are advised to be aware of presence of work sites which are delineated by adequate markings and/or protected by adequate work barricades.


